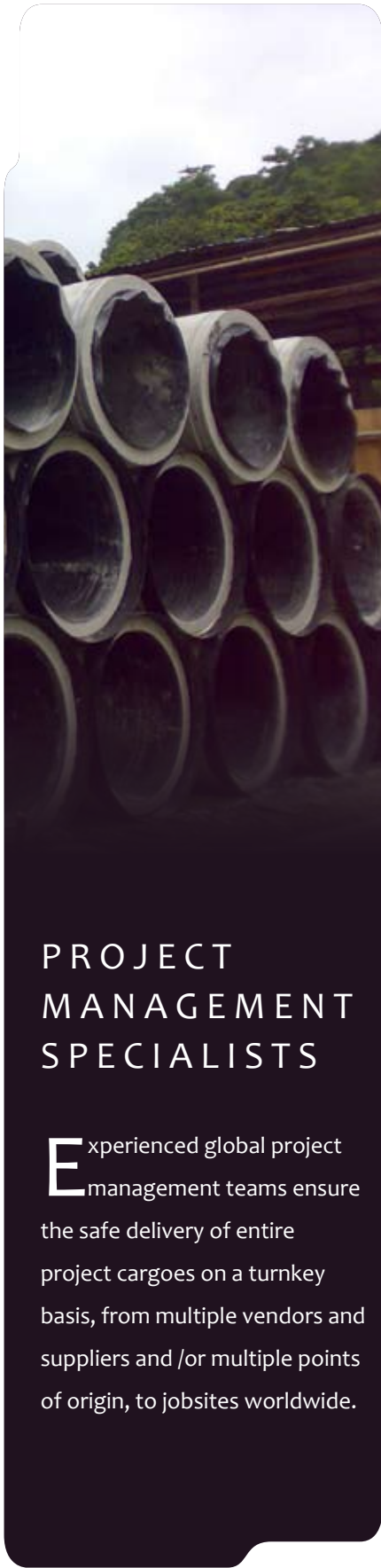

This unique and detailed software system traces and monitors cargo movements worldwide. Clients are now able to access status reports on their shipments through www.ttdglobal.net as well as download information through EDI transactions to and from their respective locations.

Project teams can also be assigned to work in the client's project offices and at the jobsite with seamless linkage to our C2C system. Turnkey solutions are initiated by our global project teams. We receive and check all cargo delivered to our depots. The cargo is then bar-coded and export packed and/or containerized as necessary. All bookings are negotiated and confirmed with the most suitable ocean or air carrier, including heavy lifts negotiated with specialized carriers. Cargo clearance is handled promptly, followed by haulage to the jobsite and inventory management.

Supporting our team management approach is our C2C materials handling, tracking and monitoring system, which tracks the status of all purchase order line items and printed reports. Utilizing bar-coded labels for all materials, cargo is tracked by P. O. Line and sub-line item, from the time a purchase order is entered into our system until the time it is delivered to the jobsite. In addition, digital images of major load-outs are e-mailed to clients to document the physical progress of their

shipments.



Other services include thorough cost analysis of all feasible transport options, as well as the combining and consolidation of specific cargoes for added cost savings. Logistics plans and site surveys can be conducted to further expedite project movements and to determine the most expeditious and competitive transportation solutions.



PROTECTION ALL THE TIME

Our warehousing and export packaging facilities provide a full range of service to meet all requirements for ocean, air and domestic shipments, including the storage and 24-hour protection of client cargoes.

Unique services include receiving, line-item checking and verification of materials, moisture barrier, vacuum packing, on-site industrial boxing, packing that meets Governmental/Military specifications, packing and marking of hazardous materials, and the consolidation and securing of equipment and supplies into containers, flat racks and platforms. In the United States, we also provide controlled-access facilities and security-cleared personnel for the handling of sensitive embassy cargo.

Through C2C, our materials tracking and monitoring system, clients can access their accounts by entry password on our website at www.ttdglobal.net. This system provides receiving reports, overage/shortage/damage reports on-hand inventory, purchase order status reports, open-item reports, export packing lists and inland bills of lading

Materials can be tracked by line-item and sub-item, from the time a purchase order is entered into our system, through delivery to the jobsite. Utilizing barcode labels for all packages, every aspect of jobsite inventory can be accomplished through this system.

COST SAVINGS & BUYING POWER

Our chartering and heavy-lift teams handle vessel and aircraft charters, contracts of carriage, and the management of specialized movements of heavy lift aircrafts, vessels, submersibles, tugs, barges and ro-ro's.

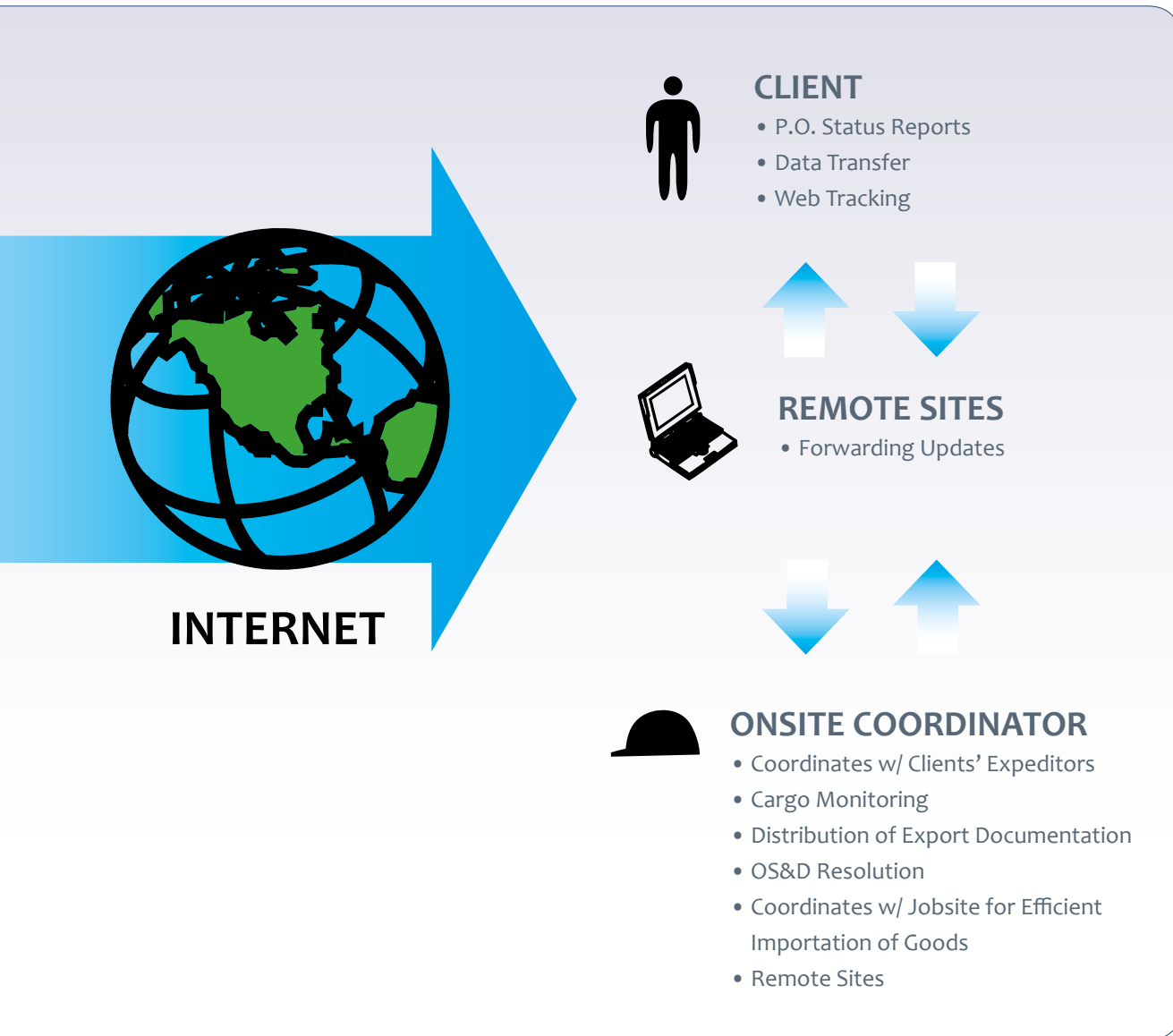

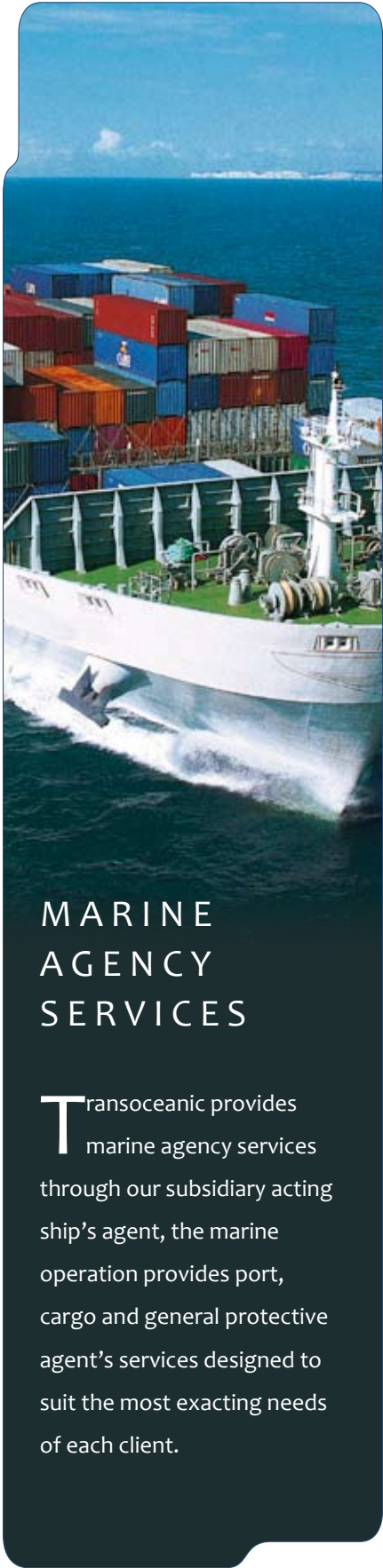
Our web-based cargo tracking system, C2C, provides our clients with instant, real-time, 24/7 access to all information and documentation related to their shipment from any computer, any location, worldwide.

Purchase orders are imported electronically, by line-item and sub-line item, and makes it immediately available to the client. It also provides complete information on all stages of a given shipment, displayed on a single page. The moment each stage is completed C2C is instantly updated, providing clients with real-time information on the status of their cargo. This data can be accessed via our website 24/7 from any computer with internet access. This provides our clients with total purchase order visibility whenever they wish to view the status of their orders.



In addition to our comprehensive tracking page, documents such as Material Receipts, Commercial Invoices/Packing List and Airway Bill/Bill of lading can be printed to a local printer. Electronic Customs Automation is used for both exported and imported cargo. Information provided by C2C can also be downloaded into Microsoft Excel to provide the client with customized reporting capabilities. Transoceanic's state-of-the-art data infrastructure allows for all methods of data transfer, such as flat file, EDI and XML. Security systems can establish a Virtual Private Network (VPN) between systems. Leased lines enable direct linkage between systems. High-speed Internet connections provide superior response and minimal latency. Data can be transferred by means ranging from the simplest methods...to the most sophisticated. Most data files are transferred via email and FTP, while formats include text delimited files, Excel, Access and XML

This fully integrated system enables us to expedite the clearance of imported cargoes while insuring that they are compliant with all government agency requirements. Our direct electronic link to the government authorities enables us to determine cargo release status, quota level status, duty rates and filing of FDA prior notices.

Other specialized areas of import transactions include temporary import bonds, customs drawback services, the filing of customs petitions and protests, door-to-door service from shipper's warehouse to importer-including marine insurance – and the admission and withdrawal of foreign Trade Zone merchandise.
